Membership Levels

Student Membership

Is open to those who have enrolled in a Diploma of Marine Surveying with the Institute or who are studying maritime qualifications in higher education institutions who are not currently working in the industry.

Associate Membership

Is open to those who have between 0-2 years experience as a marine surveyor as well as one of the following:

- A seafarer holding marine qualifications, Naval Architect, Marine Engineer, Boat Builder, Shipwright, Electrician, Marine Mechanic or other marine specialist;

OR

- Holds a Diploma of Marine surveying or is studying towards the completion of;

OR

- Is currently working as a Marine Surveyor

The maximum term for Associate Membership is 5 years.

Full Membership

Is open to those who meet one of the following criteria:

- Holds a Diploma of Marine Surveying plus a minimum of 2 years current full-time experience (or pro-rata equivalent) as a marine surveyor within Australia or New Zealand

OR

- Holds prior maritime qualifications plus 5 years current full-time experience (or pro-rata equivalent) as a marine surveyor within Australia or New Zealand

OR

- Is granted special exemption at the discretion of the board on required qualifications and/or experience or a non-traditional entry pathway

Certified Commercial Marine Surveyors™

Is available to those who fulfill all the requirements of full membership and wish to apply for Certification as a Marine Surveyor.

Additional requirements for eligibility for Certification include:

- Provide evidence of appropriate insurance coverage for work undertaken
- Provide evidence of operating under a Quality Management System as per AIMS guidelines
- Comply with AIMS yearly submission of Continuing Professional Development activities
- Strictly adhere to the AIMS Code of Professional Conduct at all times.

Both individual members as well as organisations can apply for Certification and AIMS can assist with the requirements to apply.

Continuing Professional Development

Continuing Professional Development (CPD) is a mandatory requirement for all levels of membership of the AIMS apart from students. The AIMS requires all members to undertake activities which will keep them abreast of professional developments, new skills and broaden their experience.

Members are required to obtain a minimum of 10 points per calendar year. However, points can be accrued and rolled over to the following year where a member has exceeded the minimum points in one year.

Members will need to provide evidence that they have obtained 10 points per calendar year or 30 points during each consecutive 3-year period.

Evidence is required to support CPD activities, and this may include a receipt, a copy of a certificate of attendance, email confirmation or trail, diary notation or log, or any other means of confirming CPD activities.

Continuing Professional Development activities may include but are not limited to:

- Subscriptions to magazines and industry publications.
- Attending a marine survey organisation or company technical meeting.
- Attending an industry networking event (formal or informal).
- Technical meetings or presentations in person or online.
- Short courses and workshops.
- Publication of a letter or short article in an industry magazine.
- Completion of any business management activities.
- Completion of an AIMS business or professional development short course.
- Researching and learning a new skill or mentoring a new surveyor.
- The preparation and presentation of material for courses, conferences, and seminars.
- Attendance at seminars and conferences related to the marine survey and shipping industries generally.
- Completion of an AIMS survey specific professional development program or undertaking any post-graduate study or individual tertiary short course, unit, or subject.
- Formal training course (Diploma or higher) related to marine survey that is undertaken with an assessment component.
